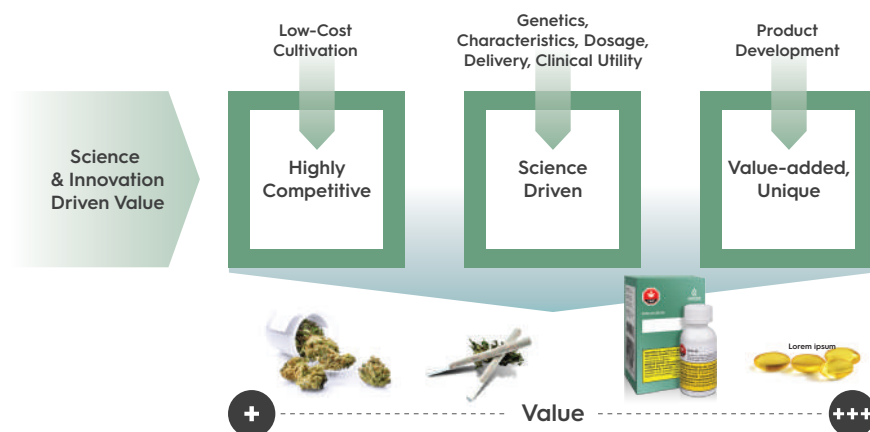

Overview

A Canadian licensed producer committed to creating new consumer experiences with recreational and wellness-oriented cannabis products. With an emphasis on innovation and production excellence, Emerald has built a platform of distinct operating assets designed to uniquely serve the Canadian marketplace and international opportunities.

Strategic Direction

- **Pure Sunfarms (PSF):** This 41.3%-owned JV's fully operational 1.1 million square foot facility is producing high quality, affordably priced products. PSF continues to focus on expanding its sales territories and brand presence as well as developing value-added oils and Cannabis 2.0 products.
- **British Columbia and Québec:** Emerald's 100%-owned facilities on the East and West Coasts of Canada are in full production. Verdélite is a premium craft operation with an 88,000 square foot indoor facility in Québec; Emerald Richmond is a health and wellness-oriented organic greenhouse (78,000 square feet operational).
- **Distribution:** Emerald supplies the Canadian recreational cannabis market and has secured agreements with nearly every province and territory. Emerald signed its first international supply agreement with STENOCARE to distribute medical cannabis in Denmark. Additionally, both Verdélite and Pure Sunfarms are licensed to distribute their unique packaged, branded dried cannabis products.
- **Cannabis 2.0 strategy:** Emerald is advancing the extraction of THC, CBD and resin at its facilities, while concurrently securing third-party, large-scale extraction and value-added product manufacturing capabilities through strategic partnerships. The product development team is advancing unique formulations and dosage forms for wellness purposes.
- **Unique branding opportunity:** 51%-owned JV, Emerald Naturals, began distribution of its health product line aimed at modulating the endocannabinoid system to potentially improve health & wellness. The products are distributed through health food, grocery and pharmacy channels and are currently available in over 313 locations, including Whole Foods and Alive Health Center.
